The Victim's representatives can prove in a Grand Jury, Civil Jury and Congressional Hearing that White House staff, U.S. Senators and their Silicon Valley financiers did order, operate and finance a massive "hit-job" on the Victim as revenge/retribution/vendetta because he reported an organized crime activity involving well known public officials.

EVERY PUBLIC OFFICIAL WHO WAS, BY LAW, SUPPOSED TO HELP THE Victim HAS, SO FAR, BEEN PROVEN BY INVESTIGATORS TO HAVE BEEN IN DIRECT BUSINESS COMPETITION WITH Victim VIA THEIR "OUTSIDE ACTIVITIES".

The effort made by political executives to steer the annual expenditure of trillions of dollars of taxpayer funds and stock market profits to one group of friends or another.

It is called "Cronyism" and it is operated by U.S. Senators and White House staff for illicit profiteering purposes.

The corrupt public officials involved here used real estate, stock market ownership, revolving door payola jobs and investment bank accounts to profiteer from each deal that the charged officials pushed.

FBI-level tracking of the covert accounts, trusts, shell corporations, family members and associates of every public official involved in this case proves that they made money by competing with the Victim's business ventures. The Panama Papers Leaks, Swiss Leaks, Snowden Leaks, and all of the other leaks prove this as fact.

Investigations have revealed that the White House and California Senators hired the character assassination and defamation attack services: Cardinal & Pine; Pacronym, Acronym; The Americano; Investing in US; Shadow Inc; Courier Newsroom; IN-Q-Tel; Gawker Media; Jalopnik; Gizmodo Media; K2 Intelligence; WikiStrat; Podesta Group; Fusion GPS; Google; YouTube; Alphabet; Facebook; Twitter; Think Progress; Media Matters); Black Cube; Correct The Record; Orbis Business Intelligence, Undercover Global Ltd; Stratfor; Jigsaw; ShareBlue/Acronym; Versa LLC; American Ledger; Supermajority News; New Venture Fund; Sixteen Thirty Fund; Cambridge Analytica; Sid Blumenthal; States Newsroom; Hopewell Fund; Open Society.; David Brock; AmpliFire News; American Bridge; Plouffe Consulting; Pantsuit Nation; MotiveAl; American Bridge 21st Century Foundation; Priorities USA; PR Firm Sunshine Sachs; The American Independent Foundation; Covington and Burling; Buzzfeed; The American Independent; Perkins Coie; Secondary Infektion; Wilson Sonsini and thousands more to run hit-jobs, character assassinations, dirty tricks and economic reprisal attacks on any targets who reported the crimes. Each of those companies are now under federal and civil investigation. Most of these businesses offer the service of manipulating elections and news coverage in order to steer stock market profits into the pockets of billionaire clients at the expense of the taxpayer and Democracy. They hide their transactions via money-laundering. All of these services, when focused on individual citizens, are lethal.

These attackers deserve to be punished for the rest of their lives for taking away the lives of others in exchange for remuneration. Any company who is corrupt enough to hire any of these assassins should be forced out of business.

These attack services are responsible for 90% of the "Fake News" problem in the world because they are the authors of most fake news. Congress must act to make these kinds of companies illegal!

These digital assassination services offer hit-jobs, character assassinations and economic reprisal programs to famous billionaires and corrupt politicians who are seeking revenge, retribution and vendetta executions.

These are the specific attacks undertaken against the victim:

- Government agency bosses solicited the target with false promises of future loans, contracts or grants from their agency and caused the target victim to expend millions of dollars and years of their time for projects which those government bosses had covertly promised to their friends. They used the target victim as a "smokescreen" to cover their illegal government slush-funds for the victims competitors and personal enemies. By using this tactic, the attackers drain the target victims funds and forced victim into an economic disaster without the government bosses fearing any reprisal for their scam in which they made billions of dollars in profit in the notorious Solyndra scandals as seen in the CBS 60 Minutes episode: "The Cleantech Crash", thousands of TV news segments and the related GAO and Congressional corruption reports.
- Government officials and LSC corporation (A federal agency dedicated to providing legal services to victims) blockaded victim's rights to legal representation in order to prevent victim from personally suing the attackers because such a lawsuit would have embarrassed corrupt public officials. High tech law firms that were discussing a services agreement with victim were threatened and ordered to not help victim or "they would be black-listed or be cut-off from tens of millions of dollars of Google, Netflix, Facebook and government contracts". Individual lawyers were threatened with black-listing and getting "flooded with more filings than you could ever respond to in your life-time..." LSC officials, who were almost entirely Obama Administration associates, refused to assist with lawyer referrals, which is against their federal contract.
- An sophisticated animated attack film was produced attacking victim. An animated film is an expensive effort involving considerable time and expense. An attacker must be well financed to undertake such an effort. The film was published on YouTube and locked onto the very top search result line on every YouTube search in front of 5 billion internet users for over a decade. The damage to victim's reputation is estimated in the tens of millions of dollars. YouTube steadfastly refused to remove or adjust the search results even though YouTube executives knew victim and knew that the video represented a character assassination attempt against victim because YouTube owners finance the political campaigns of the public officials who ordered the attacks. While Google/YouTube stated to Congress that all of it's search results are arbitrary, the never-moving search result of this attack video proved that Google's and YouTube's search results are manually manipulated by human maintained black-lists.
- Social networking sites including MeetUp, Match, Facebook, etc. and all other IAC-owned, or similar, sites (IAC is managed by Hillary Clinton's daughter, whose Mother knew victim) have had their profiles, texts, and inter-member communications, since those companies were started, hacked or purchased. The financiers of almost everyone of these sites are also the financiers of the suspects. The attack service providers use Palantir, In-Q-Tel financed data analysis software to analyze every activity in those services in order to find honey-trap, blackmail and social conflict exploitation opportunities. Your social life will, essentially, end. Every photo on every social site is cross checked with every other photo on the internet in order to cull your Facebook, Linkedin, Snapchat and other social media together to create a total manipulation profile data file on you. New contacts on these sites were contacted by the attackers and told to "avoid" the victim in order to damage victim.
- Social Security, SSI, SDI, Disability and other earned benefits were stone-walled. Applications for benefits for the victim were intentionally "lost" like a "Lois Lerner hard drive". Files in the application process "disappeared". A U.S. Senator ordered Victim's benefits to "never be approved" even though victim worked 60 hour+ weeks for decades in service to their nation and their community. A SSA official in the local SSA office, who had a devout expressed hatred against one United States President ordered a benefits blockade against victim because he found out that victim's ex-lawyer now worked in the White House.
- Government officials and tech oligarchs contacted members of the National Venture Capital association (NVCA) and created national "black-lists" to blockade victim from receiving investor funding. This was also confirmed in a widely published disclosure by Tesla Motors Daryl Siry and in published testimony. If Silicon Valley political campaign finance oligarchs black-list you (see the "AngelGate" Scandal and the "High Tech No Poaching Class Action Lawsuit" cases) you will never get investor funding again.
- Federal FOIA requests were hidden, frozen, stone-walled, delayed, lied about and only partially responded to in order to seek to hide information and run cover-ups.
- State and federal officials play an endless game of Catch-22 by arbitrarily determining that deadlines had passed that they, the government officials, had stonewalled and obfuscated applications for, in order to force these deadlines that they set, to appear to be missed.
- Victims was found to be strangely poisoned, not unlike the Alexander Litvenko case. Heavy metals and toxic materials were found right after victim's work with the Department of Energy weapons and energy facilities. Many wonder if victim was intentionally exposed to toxins in retribution for their testimony. The federal MSDS documents clearly show that a number of victims were exposed to deadly compounds and radiations, via DOE, without being provided with proper HazMat suits which DOE officials knew were required.
- Victims employers were called, and faxed, and ordered to fire target victims from their places of employment, in the middle of the day, with no notice, as a retribution tactic.
- On orders from Obama White House officials Google, YouTube, Gawker Media and Gizmodo Media produced attack articles and defamation videos. Google locked these contrived attack articles from the Nicholas Guido Denton tabloid empire on the top line, of the front page of all Google searches for a decade in front of 7.5 billion people, around the world. This attack-type uses over \$40 million dollars in server farms, production costs and internet rigging. The forensic data acquired from tracking some of these attacks proves that Google rigged these attacks against victim on the internet and that all of Google's "impressions" are manually controlled by Google's executives who are also the main financiers and policy directors of the Obama Administration. This data was provided to the European Union for it's ongoing prosecution of Google's political manipulation of public perceptions. Hired attackers Nicholas Guido Denton, John Herman, Adrian Covert, lan Fette, Patrick George, Gabrielle Darbyshire and John Cook have been referred to the FBI for surveillance, tracking and interview relative to the command, control and compensation for those attacks.
- Victims HR and employment records, on Taleo, Palantir and EVERY recruiting and hiring database, was embedded with negative keywords and "flags" in order to prevent the victim from ever gaining future employment.
- Gary D. Conley, Seth Rich, Rajeev Motwani who victim knew, and many other whistle-blowers in these matters, turned up dead under strange circumstances. Victim has received ongoing death threats for his help to federal investigations in the larger organized crime investigation relative to this matter.

- Paypal (A DNC-biased operation) and other on-line payments for on-line sales by victim are de-platformed, delayed, hidden, or re-directed in order to terminate income potential for target who competed with the attackers interests and holdings. This further denied victim income. As a test, victim built an online store with hundreds of thousands of products and marketed it globally. Trackers, placed by victim's technicians, on servers, discovered that Paypal and an outside "Virgina-based system" were DNS and payment re-directed all traffic away from the store so that victim received no traffic and no income. In DNS redirection, "website spoofing" sends target victims websites to dead ends where no sales orders or customer inquiries actually get back to the target. These internet revenue activity manipulations are conducted using outside covert servers operated by the attackers and revealed in the Snowden Leaks. All commercial storefronts and on-line sales attempts by target victims, had their sites hidden, or search engine de-linked by a massively resourced facility located in Virginia, Texas or Palo Alto, California in order to terminate revenue potentials for the victim.
- Contracted trolls, shills, botnets and synth-blog deployments are deployed to place defamatory statements and disinformation about victim in front of 7.5 billion people around the world on the internet in order to seek to damage their federal testimony credibility by a massively resourced facility. Some of these troll farms were uncovered in Russia, Ukraine, Israel and Brazil.
- Campaign finance dirty tricks contractors were hired by campaign financiers to attack the friends and family members of the target victim in order to create low morale for the target victims psyche and motivation.
- In one case covert political partner: Google, transferred large sums of cash to dirty tricks contractors and then manually locked the media portion of the attacks into the top lines of the top pages of all Google searches globally, for years, with hidden embedded codes in the links and web-pages which multiplied the attacks on Victims by many magnitudes.
- Covert Cartel financier: Google, placed Google's lawyer: Michelle Lee, in charge of the U.S. Patent Office and she, in turn, stacked all of the U.S. Patent Office IPR and ALICE review boards and offices with Google-supporting employees in order to rig the U.S. Patent Office to protect Google from being prosecuted for the vast patent thefts that Google engages in. Google has hundreds of patent lawsuits for technology theft and a number of those lawsuits refer to Google's operations as "Racketeering", "Monopolistic Cartel" and "Government Couplike" behaviors. Thousands of articles and investigations detail the fact that Google, "essentially" ran the Obama White House and provided over 80% of the key White House staff. A conflict-of-interest unlike any in American history. Google's investors personally told Victim they would "kill him". Google and the Obama Administration were "the same entity". Victim testified in the review that got Michelle Lee terminated and uncovered a tactical political and social warfare group inside Google who were financed by Federal and State funds.
- "Honeytraps" and moles were employed by the attackers. In this tactic, people who covertly worked for the attackers were employed to approach the "target" in order to spy on and misdirect the subject.
- Gawker Media, Gizmodo Media, Snopes, SPLC and other hired media assassins were retained to produce "hatchet job" character assassination articles about victim. Then those articles were faxed, mailed and emailed to Kaiser Permanente and investors with a note saying: "You don't want to have anything to do with this person, do you.?" in order to get victim fired from their job and get victim's loans or financing pulled. The attackers use their round one attack media, that they authored, to create a round two second wave attack designed to end victim's life status via economic warfare.
- Mortgage and rental applications had red flags added to them in databases to prevent the targets from getting homes or apartments.
- Krebs On Security, Wired, Ars Technica, The Wall Street Journal and most major IT publications have reported that hundreds of spy "back-doors" have been found on every Intel, AMD, Apple, Xfinity, Cisco, Microsoft, Juniper Networks motherboard, chip-set and hardware component set. This means that the attackers used a "key" code can open any of victims computer, server, router, cloud-network or other network connected device and read every file, photo, video, your calendar and email on devices at any time from any location on Earth. This has been widely reported on by Glenn Greenwald, Edward Snowden, Scahill, Cheryl K of CBS News and others. Victim was hacked at least 10 times. In a number of instances, people, who victim had been communicating with online, were mysteriously contacted by a third party who sent them the Gizmodo attack article or phoned them with warnings to avoid victim. These kinds of Man-In-The-Middle interceptions would only have been possible from hacking and MITM surveillance tactics.
- McCarthy-Era "Black-lists" were created and employed against target victims who competed with Obama Administration executives and their campaign financiers to prevent them from getting funding and future employment. This White House process is known as "RatFucking", a tactic that is documented in a variety of published reports and on Wikipedia.
- The housing rights of Victim were stalled in reprisal. Public records show that tens of thousands of other Victims were moved ahead of victim even though victim's validation metrics exceeded those of almost every other Victim. Victim was "black-listed".

Federal law enforcement, the United States Congress and the highest level investigators in the U.S., and abroad, have documented (per the "FISA Memo", Congressional Reports and federal employee testimony) and proven the fact that the Obama Administration regularly engaged in the operation of retribution, vendetta and reprisal campaigns known as "hit-jobs" against domestic natural born U.S. citizen domestic taxpayers. Second former employee of controversial data firm to be questioned by special counsel's inquiry into Russia collusion. Per Carole Cadwalladr: Brittany Kaiser is said to be cooperating fully with the Mueller inquiry. A director of the controversial data company Cambridge Analytica, who appeared with Arron Banks at the launch of the Leave.EU campaign, has been subpoenaed by the US investigation into possible collusion between the Trump campaign and the Russian government. A spokesman for Brittany Kaiser, former business development director for Cambridge Analytica which collapsed after the Observer revealed details of its misuse of Facebook data confirmed that she had been subpoenaed by special counsel Robert Mueller, and was cooperating fully with his investigation. He added that she was assisting other US congressional and legal investigations into the company's activities and had voluntarily turned over documents and data.

Kaiser, who gave evidence to the UK parliament last April in which she claimed Cambridge Analytica had carried out in-depth work for Leave.EU, is the second individual connected to the firm subpoenaed by the special counsel. The Electoral Commission has said its investigation into Leave.EU found no evidence that the campaign "received donations or paid for services from Cambridge Analytica ...beyond initial scoping work". Damian Collins, chairman of parliament's inquiry into fake news, said it was "no surprise" that Kaiser was under scrutiny by Mueller because "her work connected her to WikiLeaks, Cambridge Analytica and [its parent company] SCL, the Trump campaign, Leave.EU and Arron Banks". He said it was now vital Britain had its own inquiry into foreign interference: "We should not be leaving this to the Americans."

"Any journalists who are not beating the same drum and giving the same talking points," she insisted "pay the price" for not going along with the liberal crowd. She also called out her targeters by name.

"I know they're going to come after me," she told Hannity. "Michael Calderone who is at the Huffington Post. I can give you the script now. I can tell you who the players are. Joe Hagan. Brian Stelter." She added: "They smear you personally. They go after your integrity. They go after your reputation as a person and a professional. They will stop at nothing. I am not the only one. And I am just, I am done, right, I am tired of it. And they do not get to write my story anymore. They don't get to speak for me, I want to say loudly and clearly to anybody who is listening, I am not owned. Nobody owns me, right? I'm not owned by the left or the right." Logan made headlines recently when, during a scorched earth podcast interview with Ritland, she said that there was a lot of "weight" in most news organizations on "one side of the political spectrum." "The media everywhere is mostly liberal. But in this country, 85 percent of journalists are registered Democrats. So that's just a fact, right?" she told Ritland. She also trashed reporting based on single, anonymous government sources. "That's not journalism, that's horseshit," Logan stressed. "Responsibility for fake news begins with us. We bear some responsibility for that, and we're not taking ownership of that and addressing it. We just want to blame it all on somebody else."

Likely to dig dirt on enemies or secure records that reporters could not legally obtain, one federal law enforcement insider said. One FBI insiders aid the payments to Fusion GPS coincide with Donald Trump's run for the White House. The payments were made between Sept. 2015 and Sept. 2017, records show. The unthinkable: The mainstream media paying Fusion GPS for dirt on Trump to the same firm the Democratic National Committee paid to fund the bogus Trump dossier. And at the same time Fusion GPS bribing journalists to place stories likely negative about Trump, as well as spread the bogus Trump dossier around.

Wikileaks Unveils 'Vault 7': "The Largest Ever Publication Of Confidential CIA Documents"; Another Snowden Emerges

WikiLeaks has published what it claims is the largest ever release of confidential documents on the CIA. It includes more than 8,000 documents as part of 'Vault 7', a series of leaks on the agency, which have allegedly emerged from the CIA's Center For Cyber Intelligence in Langley, and which can be seen on the org chart below, which Wikileaks also released:

A total of 8.761 documents have been published as part of 'Year Zero', the first in a series of leaks the whistleblower organization has dubbed 'Vault 7.' WikiLeaks said that 'Year Zero' Microsoft's Windows and even Samsung TVs, which are turned into covert microphones." WikiLeaks tweeted the leak, which it claims came from a network inside the CIA's Center for Cyber Intelligence in Langley, Virginia. Among the more notable disclosures which, if confirmed, "would rock the technology world", the CIA had managed to bypass encryption on popular phone and messaging services such

revealed details of the CIA's "global covert hacking program," including "weaponized exploits" used against company products including "Apple's iPhone, Google's Android and

as Signal, WhatsApp and Telegram. According to the statement from WikiLeaks, government hackers can penetrate Android phones and collect "audio and message traffic before encryption is applied.'

Another profound revelation is that the CIA can engage in "false flag" cyberattacks which portray Russia as the assailant. Discussing the CIA's Remote Devices Branch's UMBRAGE group, Wikileaks' source notes that it "collects and maintains a substantial library of attack techniques 'stolen' from malware produced in other states including the Russian

"With UMBRAGE and related projects the CIA cannot only increase its total number of attack types but also misdirect attribution by leaving behind the "fingerprints" of the groups that the attack techniques were stolen from. UMBRAGE components cover keyloggers, password collection, webcam capture, data destruction, persistence, privilege escalation, stealth, anti-virus (PSP) avoidance and survey techniques."

But perhaps what is most notable is the purported emergence of another Snowden-type whistleblower: the source of the information told WikiLeaks in a statement that they wish to initiate a public debate about the "security, creation, use, proliferation and democratic control of cyberweapons." Policy questions that should be debated in public include "whether the CIA's hacking capabilities exceed its mandated powers and the problem of public oversight of the agency," WikiLeaks claims the source said.

The FAQ section of the release, shown below, provides further details on the extent of the leak, which was "obtained recently and covers through 2016". The time period covered in the latest leak is between the years 2013 and 2016, according to the CIA timestamps on the documents themselves. Secondly, WikiLeaks has asserted that it has not mined the entire leak and has only verified it, asking that journalists and activists do the leg work.

Among the various techniques profiled by WikiLeaks is "Weeping Angel", developed by the CIA's Embedded Devices Branch (EDB), which infests smart TVs, transforming them into covert microphones. After infestation, Weeping Angel places the target TV in a 'Fake-Off' mode, so that the owner falsely believes the TV is off when it is on. In 'Fake-Off' mode the TV operates as a bug, recording conversations in the room and sending them over the Internet to a covert CIA server.

As Kim Dotcom chimed in on Twitter, "CIA turns Smart TVs, iPhones, gaming consoles and many other consumer gadgets into open microphones" and added "CIA turned every Microsoft Windows PC in the world into spyware. Can activate backdoors on demand, including via Windows update

Dotcom also added that "Obama accused Russia of cyberattacks while his CIA turned all internet enabled consumer electronics in Russia into listening devices. Wow!"

Julian Assange, WikiLeaks editor stated that "There is an extreme proliferation risk in the development of cyber 'weapons'. Comparisons can be drawn between the uncontrolled proliferation of such 'weapons', which results from the inability to contain them combined with their high market value, and the global arms trade. But the significance of "Year Zero" goes well beyond the choice between cyberwar and cyberpeace. The disclosure is also exceptional from a political, legal and forensic perspective."

Key Highlights from the Vault 7 release so far:

- 1. "Year Zero" introduces the scope and direction of the CIA's global covert hacking program, its malware arsenal and dozens of "zero day" weaponized exploits against a wide range of U.S. and European company products, include Apple's iPhone, Google's Android and Microsoft's Windows and even Samsung TVs, which are turned into covert microphones.
- 2. Wikileaks claims that the CIA lost control of the majority of its hacking arsenal including malware, viruses, trojans, weaponized "zero day" exploits, malware remote control systems and associated documentation. This extraordinary collection, which amounts to more than several hundred million lines of code, gives its possessor the entire hacking capacity of the CIA. The archive appears to have been circulated among former U.S. government hackers and contractors in an unauthorized manner, one of whom has provided WikiLeaks with portions of the archive.
- 3. By the end of 2016, the CIA's hacking division, which formally falls under the agency's Center for Cyber Intelligence (CCI), had over 5000 registered users and had produced more than a thousand hacking systems, trojans, viruses, and other "weaponized" malware. Such is the scale of the CIA's undertaking that by 2016, its hackers had utilized more code than that used to run Facebook.
- 4. The CIA had created, in effect, its "own NSA" with even less accountability and without publicly answering the question as to whether such a massive budgetary spend on duplicating the capacities of a rival agency could be justified.
- 5. Once a single cyber 'weapon' is 'loose' it can spread around the world in seconds, to be used by rival states, cyber mafia and teenage hackers alike.

Snowden 2.0?

In a statement to WikiLeaks the source details policy questions that they say urgently need to be debated in public, including whether the CIA's hacking capabilities exceed its
mandated powers and the problem of public oversight of the agency. The source wishes to initiate a public debate about the security, creation, use, proliferation and democratic
control of cyberweapons.

CIA targets iPhones, Androids, smart TVs:

- 1. CIA malware and hacking tools are built by EDG (Engineering Development Group), a software development group within CCI (Center for Cyber Intelligence), a department belonging to the CIA's DDI (Directorate for Digital Innovation). The DDI is one of the five major directorates of the CIA (see this organizational chart of the CIA for more details).
- 2. The increasing sophistication of surveillance techniques has drawn comparisons with George Orwell's 1984, but "Weeping Angel", developed by the CIA's Embedded Devices Branch (EDB), which infests smart TVs, transforming them into covert microphones, is surely its most emblematic realization.

Also cars, suggesting that the CIA may have a role in the death of Michael Hastings:

- As of October 2014 the CIA was also looking at infecting the vehicle control systems used by modern cars and trucks.
- The purpose of such control is not specified, but it would permit the CIA to engage in nearly undetectable assassinations.

And computers:

• The CIA also runs a very substantial effort to infect and control Microsoft Windows users with its malware. This includes multiple local and remote weaponized "zero days", air gap jumping viruses such as "Hammer Drill" which infects software distributed on CD/DVDs, infectors for removable media such as USBs, systems to hide data in images or in covert disk areas ("Brutal Kangaroo") and to keep its malware infestations going.

Hoarding of Zero Day exploits:

- In the wake of Edward Snowden's leaks about the NSA, the U.S. technology industry secured a commitment from the Obama administration that the executive would disclose on an ongoing basis rather than hoard serious vulnerabilities, exploits, bugs or "zero days" to Apple, Google, Microsoft, and other US-based manufacturers.
- Serious vulnerabilities not disclosed to the manufacturers places huge swathes of the population and critical infrastructure at risk to foreign intelligence or cyber criminals who independently discover or hear rumors of the vulnerability. If the CIA can discover such vulnerabilities so can others.

Proliferation of leaked/hacked Cyberwar programs:

- While nuclear proliferation has been restrained by the enormous costs and visible infrastructure involved in assembling enough fissile material to produce a critical nuclear mass,
 cyber 'weapons', once developed, are very hard to retain. Cyber 'weapons' are in fact just computer programs which can be pirated like any other. Since they are entirely comprised
 of information they can be copied quickly with no marginal cost.
- Over the last three years the United States intelligence sector, which consists of government agencies such as the CIA and NSA and their contractors, such as Booze Allan Hamilton, has been subject to unprecedented series of data exfiltrations by its own workers.
- Once a single cyber 'weapon' is 'loose' it can spread around the world in seconds, to be used by peer states, cyber mafia and teenage hackers alike.

The U.S. Consulate in Frankfurt is a covert CIA hacker base

• In addition to its operations in Langley, Virginia the CIA also uses the U.S. consulate in Frankfurt as a covert base for its hackers covering Europe, the Middle East and Africa. CIA hackers operating out of the Frankfurt consulate ("Center for Cyber Intelligence Europe" or CCIE) are given diplomatic ("black") passports and State Department cover.

• The instructions for incoming CIA hackers make Germany's counter-intelligence efforts appear inconsequential: "Breeze through German Customs because you have your cover-for-action story down pat, and all they did was stamp your passport"

Examples of CIA projects

- The CIA's Engineering Development Group (EDG) management system contains around 500 different projects (only some of which are documented by "Year Zero") each with their own sub-projects, malware and hacker tools. The majority of these projects relate to tools that are used for penetration, infestation ("implanting"), control, and exfiltration.
- Umbrage: The CIA's Remote Devices Branch's UMBRAGE group collects and maintains a substantial library of attack techniques 'stolen' from malware produced in other states including the Russian Federation. With UMBRAGE and related projects the CIA cannot only increase its total number of attack types but also misdirect attribution by leaving behind the "fingerprints" of the groups that the attack techniques were stolen from.
- Fine Dining: Fine Dining comes with a standardized questionnaire i.e menu that CIA case officers fill out. The questionnaire is used by the agency's OSB (Operational Support Branch) to transform the requests of case officers into technical requirements for hacking attacks (typically "exfiltrating" information from computer systems) for specific operations. Among the list of possible targets of the collection are 'Asset', 'Liason Asset', 'System Administrator', 'Foreign Information Operations', 'Foreign Intelligence Agencies' and 'Foreign Government Entities'. Notably absent is any reference to extremists or transnational criminals.
- 'Improvise'; a toolset for configuration, post-processing, payload setup and execution vector selection for survey/exfiltration tools supporting all major operating systems like Windows (Bartender), MacOS (JukeBox) and Linux (DanceFloor).
- HIVE: HIVE is a multi-platform CIA malware suite and its associated control software. The project provides customizable implants for Windows, Solaris, MikroTik (used in internet routers) and Linux platforms and a Listening Post (LP)/Command and Control (C2) infrastructure to communicate with these implants. The implants are configured to communicate via HTTPS with the webserver of a cover domain; each operation utilizing these implants has a separate cover domain and the infrastructure can handle any number of cover domains.

And some key sections from the FAQ:

- What time period is covered? The years 2013 to 2016. The sort order of the pages within each level is determined by date (oldest first). WikiLeaks has obtained the CIA's creation/last modification date for each page but these do not yet appear for technical reasons. Usually the date can be discerned or approximated from the content and the page order. If it is critical to know the exact time/date contact WikiLeaks.
- What is "Vault 7" "Vault 7" is a substantial collection of material about CIA activities obtained by WikiLeaks.
- What is the total size of "Vault 7"? The series is the largest intelligence publication in history.
- When was each part of "Vault 7" obtained?: Part one was obtained recently and covers through 2016. Details on the other parts will be available at the time of publication.
- Is each part of "Vault 7" from a different source? Details on the other parts will be available at the time of publication.
- . How did WikiLeaks obtain each part of "Vault 7"? Sources trust WikiLeaks to not reveal information that might help identify them.
- . Isn't WikiLeaks worried that the CIA will act against its staff to stop the series? No. That would be certainly counter-productive.

On Tuesday 7 March 2017, WikiLeaks began its new series of leaks on the U.S. Central Intelligence Agency. Code-named "Vault 7" by WikiLeaks, it is the largest ever publication of confidential documents on the agency.

The first full part of the series, "Year Zero", comprises 8,761 documents and files from an isolated, high-security network situated inside the CIA's <u>Center for Cyber Intelligence</u> in Langley, Virgina. It follows an introductory disclosure last month of <u>CIA targeting French political parties and candidates in the lead up to the 2012 presidential election</u>.

Recently, the CIA lost control of the majority of its hacking arsenal including malware, viruses, trojans, weaponized "zero day" exploits, malware remote control systems and associated documentation. This extraordinary collection, which amounts to more than several hundred million lines of code, gives its possessor the entire hacking capacity of the CIA. The archive appears to have been circulated among former U.S. government hackers and contractors in an unauthorized manner, one of whom has provided WikiLeaks with portions of the archive.

"Year Zero" introduces the scope and direction of the CIA's global covert hacking program, its malware arsenal and dozens of "zero day" weaponized exploits against a wide range of U.S. and European company products, include Apple's iPhone, Google's Android and Microsoft's Windows and even Samsung TVs, which are turned into covert microphones.

Since 2001 the CIA has gained political and budgetary preeminence over the U.S. National Security Agency (NSA). The CIA found itself building not just its now infamous drone fleet, but a very different type of covert, globe-spanning force — its own substantial fleet of hackers. The agency's hacking division freed it from having to disclose its often controversial operations to the NSA (its primary bureaucratic rival) in order to draw on the NSA's hacking capacities.

By the end of 2016, the CIA's hacking division, which formally falls under the agency's <u>Center for Cyber Intelligence</u> (CCI), had over 5000 registered users and had produced more than a thousand hacking systems, trojans, viruses, and other "weaponized" malware. Such is the scale of the CIA's undertaking that by 2016, its hackers had utilized more code than that used to run Facebook. The CIA had created, in effect, its "own NSA" with even less accountability and without publicly answering the question as to whether such a massive budgetary spend on duplicating the capacities of a rival agency could be justified.

In a statement to WikiLeaks the source details policy questions that they say urgently need to be debated in public, including whether the CIA's hacking capabilities exceed its mandated powers and the problem of public oversight of the agency. The source wishes to initiate a public debate about the security, creation, use, proliferation and democratic control of cyberweapons.

Once a single cyber 'weapon' is 'loose' it can spread around the world in seconds, to be used by rival states, cyber mafia and teenage hackers alike.

Julian Assange, WikiLeaks editor stated that "There is an extreme proliferation risk in the development of cyber 'weapons'. Comparisons can be drawn between the uncontrolled proliferation of such 'weapons', which results from the inability to contain them combined with their high market value, and the global arms trade. But the significance of "Year Zero" goes well beyond the choice between cyberwar and cyberpeace. The disclosure is also exceptional from a political, legal and forensic perspective."

Wikileaks has carefully reviewed the "Year Zero" disclosure and published substantive CIA documentation while avoiding the distribution of 'armed' cyberweapons until a consensus emerges on the technical and political nature of the CIA's program and how such 'weapons' should analyzed, disarmed and published.

Wikileaks has also decided to <u>redact</u> and anonymise some identifying information in "Year Zero" for in depth analysis. These redactions include ten of thousands of CIA targets and attack machines throughout Latin America, Europe and the United States. While we are aware of the imperfect results of any approach chosen, we remain committed to our publishing model and note that the quantity of published pages in "Vault 7" part one ("Year Zero") already eclipses the total number of pages published over the first three years of the Edward Snowden NSA leaks.

Analysis

CIA malware targets iPhone, Android, smart TVs

CIA malware and hacking tools are built by EDG (Engineering Development Group), a software development group within CCI (Center for Cyber Intelligence), a department belonging to

the CIA's DDI (Directorate for Digital Innovation). The DDI is one of the five major directorates of the CIA (see this organizational chart of the CIA for more details).

The EDG is responsible for the development, testing and operational support of all backdoors, exploits, malicious payloads, trojans, viruses and any other kind of malware used by the CIA in its covert operations world-wide.

The increasing sophistication of surveillance techniques has drawn comparisons with George Orwell's 1984, but "Weeping Angel", developed by the CIA's <u>Embedded Devices Branch</u> (<u>EDB</u>), which infests smart TVs, transforming them into covert microphones, is surely its most emblematic realization.

The attack against <u>Samsung smart TVs</u> was developed in cooperation with the United Kingdom's MI5/BTSS. After infestation, Weeping Angel places the target TV in a 'Fake-Off' mode, so that the owner falsely believes the TV is off when it is on. In 'Fake-Off' mode the TV operates as a bug, recording conversations in the room and sending them over the Internet to a covert CIA server.

As of October 2014 the CIA was also looking at infecting the vehicle control systems used by modern cars and trucks. The purpose of such control is not specified, but it would permit the CIA to engage in nearly undetectable assassinations.

The CIA's Mobile Devices Branch (MDB) developed <u>numerous attacks to remotely hack and control popular smart phones</u>. Infected phones can be instructed to send the CIA the user's geolocation, audio and text communications as well as covertly activate the phone's camera and microphone.

Despite iPhone's minority share (14.5%) of the global smart phone market in 2016, a specialized unit in the CIA's Mobile Development Branch produces malware to infest, control and exfiltrate data from iPhones and other Apple products running iOS, such as iPads. CIA's arsenal includes <u>numerous local and remote "zero days"</u> developed by CIA or obtained from GCHQ, NSA, FBI or purchased from cyber arms contractors such as Baitshop. The disproportionate focus on iOS may be explained by the popularity of the iPhone among social, political, diplomatic and business elites.

A <u>similar unit targets Google's Android which is used to run the majority of the world's smart phones (~85%) including Samsung, HTC and Sony.</u> 1.15 billion Android powered phones were sold last year. "Year Zero" shows that as of 2016 <u>the CIA had 24 "weaponized" Android "zero days"</u> which it has developed itself and obtained from GCHQ, NSA and cyber arms contractors.

These techniques permit the CIA to bypass the encryption of WhatsApp, Signal, Telegram, Wiebo, Confide and Cloackman by hacking the "smart" phones that they run on and collecting audio and message traffic before encryption is applied.

CIA malware targets Windows, OSx, Linux, routers

The CIA also runs a very substantial effort to infect and control Microsoft Windows users with its malware. This includes multiple local and remote weaponized "zero days", air gap jumping viruses such as "Hammer Drill" which infects software distributed on CD/DVDs, infectors for removable media such as USBs, systems to hide data in images or in covert disk areas ("Brutal Kangaroo") and to keep its malware infestations going.

Many of these infection efforts are pulled together by the CIA's <u>Automated Implant Branch (AIB)</u>, which has developed several attack systems for automated infestation and control of CIA malware, such as "Assassin" and "Medusa".

Attacks against Internet infrastructure and webservers are developed by the CIA's Network Devices Branch (NDB).

The CIA has developed automated multi-platform malware attack and control systems covering Windows, Mac OS X, Solaris, Linux and more, such as EDB's "HIVE" and the related "Cutthroat" and "Swindle" tools, which are described in the examples section below.

CIA 'hoarded' vulnerabilities ("zero davs")

In the wake of Edward Snowden's leaks about the NSA, the U.S. technology industry secured a commitment from the Obama administration that the executive would disclose on an ongoing basis — rather than hoard — serious vulnerabilities, exploits, bugs or "zero days" to Apple, Google, Microsoft, and other US-based manufacturers.

Serious vulnerabilities not disclosed to the manufacturers places huge swathes of the population and critical infrastructure at risk to foreign intelligence or cyber criminals who independently discover or hear rumors of the vulnerability. If the CIA can discover such vulnerabilities so can others.

The U.S. government's commitment to the <u>Vulnerabilities Equities Process</u> came after significant lobbying by US technology companies, who risk losing their share of the global market over real and perceived hidden vulnerabilities. The government stated that it would disclose all pervasive vulnerabilities discovered after 2010 on an ongoing basis.

"Year Zero" documents show that the CIA breached the Obama administration's commitments. Many of the vulnerabilities used in the CIA's cyber arsenal are pervasive and some may already have been found by rival intelligence agencies or cyber criminals.

As an example, specific CIA malware revealed in "Year Zero" is able to penetrate, infest and control both the Android phone and iPhone software that runs or has run presidential Twitter accounts. The CIA attacks this software by using undisclosed security vulnerabilities ("zero days") possessed by the CIA but if the CIA can hack these phones then so can everyone else who has obtained or discovered the vulnerability. As long as the CIA keeps these vulnerabilities concealed from Apple and Google (who make the phones) they will not be fixed, and the phones will remain hackable.

The same vulnerabilities exist for the population at large, including the U.S. Cabinet, Congress, top CEOs, system administrators, security officers and engineers. By hiding these security flaws from manufacturers like Apple and Google the CIA ensures that it can hack everyone; at the expense of leaving everyone hackable.

'Cyberwar' programs are a serious proliferation risk

Cyber 'weapons' are not possible to keep under effective control.

While nuclear proliferation has been restrained by the enormous costs and visible infrastructure involved in assembling enough fissile material to produce a critical nuclear mass, cyber 'weapons', once developed, are very hard to retain.

Cyber 'weapons' are in fact just computer programs which can be pirated like any other. Since they are entirely comprised of information they can be copied quickly with no marginal cost.

Securing such 'weapons' is particularly difficult since the same people who develop and use them have the skills to exfiltrate copies without leaving traces — sometimes by using the very same 'weapons' against the organizations that contain them. There are substantial price incentives for government hackers and consultants to obtain copies since there is a global "vulnerability market" that will pay hundreds of thousands to millions of dollars for copies of such 'weapons'. Similarly, contractors and companies who obtain such 'weapons' sometimes use them for their own purposes, obtaining advantage over their competitors in selling 'hacking' services.

Over the last three years the United States intelligence sector, which consists of government agencies such as the CIA and NSA and their contractors, such as Booze Allan Hamilton, has been subject to unprecedented series of data exfiltrations by its own workers.

A number of intelligence community members not yet publicly named have been arrested or subject to federal criminal investigations in separate incidents.

Most visibly, on February 8, 2017 a U.S. federal grand jury indicted Harold T. Martin III with 20 counts of mishandling classified information. The Department of Justice alleged that it seized some 50,000 gigabytes of information from Harold T. Martin III that he had obtained from classified programs at NSA and CIA, including the source code for numerous hacking tools

Once a single cyber 'weapon' is 'loose' it can spread around the world in seconds, to be used by peer states, cyber mafia and teenage hackers alike.

In addition to its operations in Langley, Virginia the CIA also uses the U.S. consulate in Frankfurt as a covert base for its hackers covering Europe, the Middle East and Africa.

CIA hackers operating out of the Frankfurt consulate ("Center for Cyber Intelligence Europe" or CCIE) are given diplomatic ("black") passports and State Department cover. The instructions for incoming CIA hackers make Germany's counter-intelligence efforts appear inconsequential: "Breeze through German Customs because you have your cover-for-action story down pat, and all they did was stamp your passport"

Your Cover Story (for this trip)

Q: Why are you here?

A: Supporting technical consultations at the Consulate.

Two earlier WikiLeaks publications give further detail on CIA approaches to customs and secondary screening procedures.

Once in Frankfurt CIA hackers can travel without further border checks to the 25 European countries that are part of the Shengen open border area — including France, Italy and Switzerland.

A number of the CIA's electronic attack methods are designed for physical proximity. These attack methods are able to penetrate high security networks that are disconnected from the internet, such as police record database. In these cases, a CIA officer, agent or allied intelligence officer acting under instructions, physically infiltrates the targeted workplace. The attacker is provided with a USB containing malware developed for the CIA for this purpose, which is inserted into the targeted computer. The attacker then infects and exhiltrates data to removable media. For example, the CIA attack system Fine Dining, provides 24 decoy applications for CIA spies to use. To witnesses, the spy appears to be running a program showing videos (e.g VLC), presenting slides (Prezi), playing a computer game (Breakout2, 2048) or even running a fake virus scanner (Kaspersky, McAfee, Sophos). But while the decoy application is on the screen, the underlaying system is automatically infected and ransacked.

How the CIA dramatically increased proliferation risks

In what is surely one of the most astounding intelligence own goals in living memory, the CIA structured its classification regime such that for the most market valuable part of "Vault 7" — the CIA's weaponized malware (implants + zero days), Listening Posts (LP), and Command and Control (C2) systems — the agency has little legal recourse.

The CIA made these systems unclassified

Why the CIA chose to make its cyberarsenal unclassified reveals how concepts developed for military use do not easily crossover to the 'battlefield' of cyber 'war'.

To attack its targets, the CIA usually requires that its implants communicate with their control programs over the internet. If CIA implants, Command & Control and Listening Post software were classified, then CIA officers could be prosecuted or dismissed for violating rules that prohibit placing classified information onto the Internet. Consequently the CIA has secretly made most of its cyber spying/war code unclassified. The U.S. government is not able to assert copyright either, due to restrictions in the U.S. Constitution. This means that cyber 'arms' manufactures and computer hackers can freely "pirate" these 'weapons' if they are obtained. The CIA has primarily had to rely on obfuscation to protect its malware secrets.

Conventional weapons such as missiles may be fired at the enemy (i.e into an unsecured area). Proximity to or impact with the target detonates the ordnance including its classified parts. Hence military personnel do not violate classification rules by firing ordnance with classified parts. Ordnance will likely explode. If it does not, that is not the operator's intent.

Over the last decade U.S. hacking operations have been increasingly dressed up in military jargon to tap into Department of Defense funding streams. For instance, attempted "malware injections" (commercial jargon) or "implant drops" (NSA jargon) are being called "fires" as if a weapon was being fired. However the analogy is questionable.

Unlike bullets, bombs or missiles, most CIA malware is designed to live for days or even years after it has reached its 'target'. CIA malware does not "explode on impact" but rather permanently infests its target. In order to infect target's device, copies of the malware must be placed on the target's devices, giving physical possession of the malware to the target. To exfiltrate data back to the CIA or to await further instructions the malware must communicate with CIA Command & Control (C2) systems placed on internet connected servers. But such servers are typically not approved to hold classified information, so CIA command and control systems are also made unclassified.

A successful 'attack' on a target's computer system is more like a series of complex stock maneuvers in a hostile take-over bid or the careful planting of rumors in order to gain control over an organization's leadership rather than the firing of a weapons system. If there is a military analogy to be made, the infestation of a target is perhaps akin to the execution of a whole series of military maneuvers against the target's territory including observation, infiltration, occupation and exploitation.

Evading forensics and anti-virus

A series of standards lay out CIA malware infestation patterns which are likely to assist forensic crime scene investigators as well as Apple, Microsoft, Google, Samsung, Nokia, Blackberry, Siemens and anti-virus companies attribute and defend against attacks.

"Tradecraft DO's and DON'Ts" contains CIA rules on how its malware should be written to avoid fingerprints implicating the "CIA, US government, or its witting partner companies" in "forensic review". Similar secret standards cover the use of encryption to hide CIA hacker and malware communication (pdf), describing targets & exhitrated data (pdf) as well as executing payloads (pdf) and persisting (pdf) in the target's machines over time.

CIA hackers developed successful attacks against most well known anti-virus programs. These are documented in <u>AV defeats, Personal Security Products, Detecting and defeating PSPs</u> and <u>PSP/Debugger/RE Avoidance</u>. For example, Comodo was defeated by <u>CIA malware placing itself in the Window's "Recycle Bin"</u>. While Comodo 6.x has a <u>"Gaping Hole of DOOM"</u>.

CIA hackers discussed what the NSA's "Equation Group" hackers did wrong and how the CIA's malware makers could avoid similar exposure.

Examples

The CIA's Engineering Development Group (EDG) management system contains around 500 different projects (only some of which are documented by "Year Zero") each with their own sub-projects, malware and hacker tools.

The majority of these projects relate to tools that are used for penetration, infestation ("implanting"), control, and exfiltration.

Another branch of development focuses on the development and operation of Listening Posts (LP) and Command and Control (C2) systems used to communicate with and control CIA implants; special projects are used to target specific hardware from routers to smart TVs.

Some example projects are described below, but see the table of contents for the full list of projects described by WikiLeaks' "Year Zero".

UMBRAGE

The CIA's hand crafted hacking techniques pose a problem for the agency. Each technique it has created forms a "fingerprint" that can be used by forensic investigators to attribute multiple different attacks to the same entity.

This is analogous to finding the same distinctive knife wound on multiple separate murder victims. The unique wounding style creates suspicion that a single murderer is responsible. As soon one murder in the set is solved then the other murders also find likely attribution.

The CIA's Remote Devices Branch's UMBRAGE group collects and maintains a substantial library of attack techniques 'stolen' from malware produced in other states including the Russian Federation.

With UMBRAGE and related projects the CIA cannot only increase its total number of attack types but also misdirect attribution by leaving behind the "fingerprints" of the groups that the attack techniques were stolen from.

UMBRAGE components cover keyloggers, password collection, webcam capture, data destruction, persistence, privilege escalation, stealth, anti-virus (PSP) avoidance and survey techniques.

Fine Dining

Fine Dining comes with a standardized questionnaire i.e menu that CIA case officers fill out. The questionnaire is used by the agency's OSB (<u>Operational Support Branch</u>) to transform the requests of case officers into technical requirements for hacking attacks (typically "exfiltrating" information from computer systems) for specific operations. The questionnaire allows the OSB to identify how to adapt existing tools for the operation, and communicate this to CIA malware configuration staff. The OSB functions as the interface between CIA operational staff and the relevant technical support staff.

Among the list of possible targets of the collection are 'Asset', 'Liason Asset', 'System Administrator', 'Foreign Information Operations', 'Foreign Intelligence Agencies' and 'Foreign Government Entities'. Notably absent is any reference to extremists or transnational criminals. The 'Case Officer' is also asked to specify the environment of the target like the type of computer, operating system used, Internet connectivity and installed anti-virus utilities (PSPs) as well as a list of file types to be exfiltrated like Office documents, audio, video, images or custom file types. The 'menu' also asks for information if recurring access to the target is possible and how long unobserved access to the computer can be maintained. This information is used by the CIA's 'JQJIMPROVISE' software (see below) to configure a set of CIA malware suited to the specific needs of an operation.

Improvise (JQJIMPROVISE)

'Improvise' is a toolset for configuration, post-processing, payload setup and execution vector selection for survey/exfiltration tools supporting all major operating systems like Windows (Bartender), MacOS (JukeBox) and Linux (DanceFloor). Its configuration utilities like Margarita allows the NOC (Network Operation Center) to customize tools based on requirements from 'Fine Dining' questionairies.

HIVE

HIVE is a multi-platform CIA malware suite and its associated control software. The project provides customizable implants for Windows, Solaris, MikroTik (used in internet routers) and Linux platforms and a Listening Post (LP)/Command and Control (C2) infrastructure to communicate with these implants.

The implants are configured to communicate via HTTPS with the webserver of a cover domain; each operation utilizing these implants has a separate cover domain and the infrastructure can handle any number of cover domains.

Each cover domain resolves to an IP address that is located at a commercial VPS (Virtual Private Server) provider. The public-facing server forwards all incoming traffic via a VPN to a 'Blot' server that handles actual connection requests from clients. It is setup for optional SSL client authentication: if a client sends a valid client certificate (only implants can do that), the connection is forwarded to the 'Honeycomb' toolserver that communicates with the implant; if a valid certificate is missing (which is the case if someone tries to open the cover domain website by accident), the traffic is forwarded to a cover server that delivers an unsuspicious looking website.

The Honeycomb toolserver receives exfiltrated information from the implant; an operator can also task the implant to execute jobs on the target computer, so the toolserver acts as a C2 (command and control) server for the implant.

Similar functionality (though limited to Windows) is provided by the RickBobby project.

See the classified <u>user</u> and <u>developer</u> guides for HIVE.

FREQUENTLY ASKED QUESTIONS

Why now?

WikiLeaks published as soon as its verification and analysis were ready.

In Febuary the Trump administration has issued an Executive Order calling for a "Cyberwar" review to be prepared within 30 days.

While the review increases the timeliness and relevance of the publication it did not play a role in setting the publication date.

Redactions

Names, email addresses and external IP addresses have been redacted in the released pages (70,875 redactions in total) until further analysis is complete.

- 1. **Over-redaction:** Some items may have been redacted that are not employees, contractors, targets or otherwise related to the agency, but are, for example, authors of documentation for otherwise public projects that are used by the agency.
- 2. **Identity vs. person:** the redacted names are replaced by user IDs (numbers) to allow readers to assign multiple pages to a single author. Given the redaction process used a single person may be represented by more than one assigned identifier but no identifier refers to more than one real person.
- 3. Archive attachments (zip, tar.gz, ...) are replaced with a PDF listing all the file names in the archive. As the archive content is assessed it may be made available; until then the archive is reducted
- 4. Attachments with other binary content are replaced by a hex dump of the content to prevent accidental invocation of binaries that may have been infected with weaponized CIA malware. As the content is assessed it may be made available; until then the content is redacted.
- 5. The **tens of thousands of routable IP addresses references** (including more than 22 thousand within the United States) that correspond to possible targets, CIA covert listening post servers, intermediary and test systems, are redacted for further exclusive investigation.
- 6. Binary files of non-public origin are only available as dumps to prevent accidental invocation of CIA malware infected binaries.

Organizational Chart

The organizational chart corresponds to the material published by WikiLeaks so far.

Since the organizational structure of the CIA below the level of Directorates is not public, the placement of the EDG and its branches within the org chart of the agency is reconstructed from information contained in the documents released so far. It is intended to be used as a rough outline of the internal organization; please be aware that the reconstructed org chart is incomplete and that internal reorganizations occur frequently.

And that is only a tiny part of the arsenal that is now being used against reporters who write articles critical of Elon Musk, John Podesta, Google or their political candidates. These tools and tactics are used against business competitors and ordinary citizens who speak out about crimes that Silicon Valley politicos engage in.

Everything you just read in the previous lists is now being aimed at you to seek out your weaknesses for your competitors and ideological opposition to use to try to destroy you.

Silicon Valley's In-Q-Tel private services spy company has also developed a special technology laboratory in Silicon Valley, called Lab41, to provide tools for the intelligence community to connect the dots in large sets of data. In February, Lab41 published an article exploring the ways in which a Twitter user's location could be predicted with a degree of certainty through the location of the user's friends. On Github, an open source website for developers, Lab41 currently has a project to ascertain the "feasibility of using architectures such as Convolutional and Recurrent Neural Networks to classify the positive, negative, or neutral sentiment of Twitter messages towards a specific topic." Collecting intelligence on foreign adversaries has potential benefits for counterterrorism, but such CIA-supported surveillance technology is also used for domestic law enforcement and by the private sector to spy on activist groups. Palantir, one of In-Q-Tel's earliest investments in the social media analytics realm, was exposed in 2011 by the hacker group LutzSec to be in negotiation for a proposal to track labor union activists and other critics of the U.S. Chamber of Commerce, the largest business lobbying group in Washington. The company, now celebrated as a "tech unicom" — a term for start-ups that reach over \$1 billion in valuation — distanced itself from the plan after it was exposed in a cache of leaked emails from the now-defunct firm HBGary Federal.

The Silicon hacks worked to rig Obama's election into office and the following Mid-Terms, were over-ridden for the 2016 election and are being tripled down on for the Mid-Terms following Trump's election and for 2020.

Yet other In-Q-Tel-backed companies are now openly embracing the practice. Geofeedia, for instance, promotes its research into Greenpeace activists, student demonstrations, minimum wage advocates, and other political movements. Police departments in Oakland, Chicago, Detroit, and other major municipalities have contracted with Geofeedia, as well as private firms such as the Mall of America and McDonald's. Although these Silicon Valley "Big Data" systems have missed every major terror attack, Google's investors keep selling their crap software and failed "Big Data" services to the U.S. Government.

Lee Guthman, an executive at Geofeedia, told reporter John Knefel that his company could predict the potential for violence at Black Lives Matter protests just by using the location and sentiment of tweets. Guthman said the technology could gauge sentiment by attaching "positive and negative points" to certain phrases, while measuring "proximity of words to certain words." Privacy advocates, however, have expressed concern about these sorts of automated judgments. "When you have private companies deciding which algorithms get you a so-called threat score, or make you a person of interest, there's obviously room for targeting people based on viewpoints or even unlawfully targeting people based on race or religion," said Lee Rowland, a senior staff attorney with the American Civil Liberties Union.

Meet "CrowdStrike"

Counterpunch put out a very important article earlier today on the topic, adding several crucial nuggets of information. First there's this:

The investigation methods used to come to the conclusion that the Russian Government led the hacks of the <u>DNC</u>, <u>Clinton</u> Campaign Chair John Podesta, and the DCCC were further called into question by a recent BuzzFeed <u>report</u> by Jason Leopold, who has developed a notable reputation from leading several non-partisan Freedom of Information Act lawsuits for investigative journalism purposes. On March 15 that the Department of Homeland Security released just two heavily redacted pages of unclassified information in response to an FOIA request for definitive evidence of Russian election interference allegations. Leopold wrote, "what the agency turned over to us and Ryan Shapiro, a PhD candidate at MIT and a research affiliate at Harvard University, is truly bizarre: a two-page intelligence assessment of the incident, dated Aug. 22, 2016, that contains information DHS culled from the internet. It's all unclassified — yet DHS covered nearly everything in wide swaths of black ink. Why? Not because it would threaten national security, but because it would reveal the methods DHS uses to gather intelligence, methods that may amount to little more than using Google."

That's weird enough, but it gets far stranger. For example:

In lieu of substantive evidence provided to the public that the alleged hacks which led to Wikileaks releases of DNC and Clinton Campaign Manager John Podesta's emails were orchestrated by the Russian Government, CrowdStrike's bias has been cited as undependable in its own assessment, in addition to its skeptical methods and conclusions. The firm's CTO and co-founder, Dmitri Alperovitch, is a senior fellow at the Atlantic Council, a think tank with openly anti-Russian sentiments that is funded by Ukrainian billionaire Victor Pinchuk, who also happened to donate at least \$10 million to the Clinton Foundation.

In 2013, the Atlantic Council awarded Hillary Clinton it's Distinguished International Leadership Award. In 2014, the Atlantic Council hosted one of several events with former Ukrainian Prime Minister Arseniy Yatsenyuk, who took over after pro-Russian President Viktor Yanukovych was ousted in early 2014, who nowlives in exile in Russia.

Recall that the FBI was denied access to the DNC servers by the DNC itself, and simply agreed to rely on the results provided by CrowdStrike, which as you can see has ties to all sorts of anti-Russia organizations and individuals. I find it absolutely remarkable that James Comey head of the FBI outsourced his job to CrowdStrike.

There remains zero evidence that Russia hacked the DNC. I repeat, there remains zero evidence that Russia hacked the DNC.

As cybersecurity expert Jeffrey Carr noted:

Jeffrey Carr. called the FBI/Department of Homeland Security Report, the only alleged evidence released by intelligence officials, released in late December 2016 a "fatally flawed effort" that provided no evidence to substantiate the claims that the Russian government conducted the hacks, though that's what it was purported to do.

Absolutely remarkable, but there's more. As $\underline{\textit{TechCrunch}}$ reported back in 2015:

If you need proof that security is a red hot market these days, howabout this morning's announcement that cybersecurity company CrowdStrike landed a \$100 million Series C investment round?

The round was led by Google Capital with Rackspace, which happens to be one of the company's customers also investing. Existing investors Accel and Warburg Pincus also participated. Today's investment brings the total to-date to \$156 million.

Why do I find it interesting that Google was a major investor in CrowdStrike? Well for one, we know that Chairman of Alphabet, Inc. (Google's parent company), Eric Schmidt, was actively working to help the Hillary campaign. As I highlighted in the 2015 post, Meet "Groundwork" — Google Chairman Eric Schmidt's Stealth Startup Working to Make Hillary Clinton President:

An under-the-radar startup funded by billionaire Eric Schmidt has become a major technology vendor for Hillary Clinton's presidential campaign, underscoring the bonds between Silicon Valley and Democratic politics.

The Groundwork, according to Democratic campaign operatives and technologists, is part of efforts by Schmidt—the executive chairman of Google parent-company Alphabet—to ensure that Clinton has the engineering talent needed to win the election. And it is one of a series of quiet investments by Schmidt that recognize howmodern political campaigns are run, with data analytics and digital outreach as vital ingredients that allowcandidates to find, court, and turn out critical voter blocs.

There is also another gap in play: The shrinking distance between Google and the Democratic Party. Former Google executive Stephanie Hannon is the Clinton campaign's chief technology officer, and a host of ex-Googlers are currently employed as high-ranking technical staff at the Obama White House. Schmidt, for his part, is one of the most powerful donors in the Democratic Party—and his influence does not stem only from his wealth, estimated by Forbes at more than \$10 billion.

According to campaign finance disclosures, Clinton's campaign is the Groundwork's only political client. Its employees are mostly back-end software developers with experience at blue-chip tech firms like Netflix, Dreamhost, and Google.

Since Democrats seem so obsessed with the saying these days, "where there's smoke there's fire," and there's plenty of smoke here.

Investigators are examining whether Google's far-left news site manipulation played any role last year in a 2008 cyber operation that dramatically widened the reach of news stories—some fictional—that favored Obama's and Clinton's presidential bid, people familiar with the inquiry say.

Operatives for Google/Soros appear to have strategically timed the computer commands, known as "bots," to blitz social media with links to the pro-left stories at times when the multi-billionaire Silicon Valley Cartel of businessmen were on the defensive in the Presidential races these sources said.

The bots' end products were largely millions of Twitter and Facebook posts carrying links to stories on lefty internet sites such as Huffpo News and CNN, as well as on the Soros-backed Move-on and Black Lives Matter News, the sources said. Some of the stories were false or mixed fact and fiction, said the sources, who spoke on condition of anonymity because the bot attacks are part of an FBHed investigation into a multifaceted Google-based operation to influence multiple year's elections.

Investigators examining the bot attacks are exploring whether the far-left news operations took any actions to assist Soros's operatives. Their participation, however, wasn't necessary for the bots to amplify their news through Twitter and Facebook.

The investigation of the bot-engineered traffic, which appears to be in its early stages, is being driven by the FBI's Counterintelligence Division, whose inquiries rarely result in criminal charges and whose main task has been to reconstruct the nature of the Soros's cyber attack and determine ways to prevent another.

An FBI spokesman declined to comment on the inquiry into the use of bots.

Soros-generated bots are one piece of a cyber puzzle that counterintelligence agents have sought to solve for nearly a year to determine the extent of the Deep State government's electronic broadside.

"This may be one of the most highly impactful information operations in the history of intelligence," said one former U.S. intelligence official, who spoke on condition of anonymity because of the sensitivity of the matter.

Some on the House Intelligence Committee, one of multiple congressional panels examining Soros's intervention, said that there was "circumstantial evidence of collusion." There also is "direct evidence . . . of deception, and that's where we begin the investigation,"

As for the bots, they carried links not only to news stories but also to Soros driven propaganda.

As an example, bots had spread links to try to sell the lie that the stories that accused Democratic leaders of not having involvement in running a child-sex ring in the basement of a Washington pizza parlor were off in base. In fact, the FBI has now arrested large numbers of pedophiles associated with the Democratic party. Over 40 Democratic registered Disney employees were arrested on underage sex charges. PizzaGate is no lie and the huge numbers of arrests prove that Democrats love underage sex abuse.

The study of bot-generated Twitter traffic during Obama's campaign debates showed that bot messages favorable to Obama significantly outnumbered those sympathetic to his opposition and they were controlled by Google.

Research showed that Americans who call themselves "patriotic programmers" also activated bots to aid Obama and Clinton. In interviews, they described coding the computer commands in their spare time.

Counterintelligence investigators with more cyber-sleuthing capabilities, have established that Soros and Google were the source of the bot attacks which favored Obama and Clinton and sought to rig their elections.

Soros and Elon Musk also used "trolls," hundreds of computer operatives who pretended to be Lefty or Tesla supporters and posted stories or comments on the internet complimentary to Obama, Musk or Clinton or disparaging to Trump. Sources close to the inquiry said those operatives likely worked from a facility in St. Petersburg, dedicated to that tactic.

"Soros bots and Google internet trolls sought to propagate stories underground," said a former senior Pentagon official during the Obama administration whose job focused on Memes. "Those stories got amplified by fringe elements of our media like CNN."

"They very carefully timed release of information to shift the news cycle away from stories that clearly hurt Mr. Obma, such as his inappropriate conduct over the years," he said, referring to Obama's epic scandals in which Obama bragged about grabbing taxpayers cash for his Silicon Valley crony's. That event corresponded with a surge in bot-related traffic spreading anti-Trump stories.

An additional Soros tool was the news from its prime propaganda machine, CNN with a global television and digital media operation and a U.S. arm alongside pro-immigrant Univision.

Last Nov. 19, Breitbart announced that its website traffic had set a record the previous 31 days with 300 million page views, driven substantially by social media.

Breitbart, which has drawn criticism for pursuing a nationalist agenda, was formerly led by Stephen Bannon, who became chief executive officer of Trump's election campaign last August and now serves as Trump's strategic adviser in the White House. The news site's former national security editor, Sebastian Gorka, was a national security adviser to Trump's campaign and presidential transition team. He now works as a key Trump counterterrorism adviser.

Breitbart's chief executive officer, Larry Solov, did not respond to phone and email requests seeking comment but privately many think they have the feeling that Solov feels that Obama and Clinton were smooth mobsters who raped the taxpayers for trillions of dollars

Breitbart is partially owned by Robert Mercer, the wealthy co-chief executive of a New York hedge fund and a co-owner of Cambridge Analytica, a small, London-based firm credited with giving Trump a significant advantage in gauging voter priorities last year by providing his campaign with at least 5,000 data points on each of 220 million Americans.

InfoWars is published by Alex Jones, a Texas-based conservative talk show host known for embracing conspiracy theories such as one asserting that the U.S. government was involved in the terror attacks of Sept. 11, 2001. During the 2016 campaign, InfoWars.com was a loyal Trump public relations tool. Trump was on Jones' show and praised his reporting.

"it's the major source of everything," Roger Stone, a longtime Trump confidant and campaign adviser, said last fall. Stone, who has regularly appeared on Jones' show and was on Monday, has said he invites an FBI investigation into his campaign role. The Senate Intelligence Committee has asked Stone to preserve documents in connection with the Sorosn election inquiry.

Jones responded to questions from McClatchy on his talk show.

"I'm not gonna sit here and say, 'I'm not a Soros stooge,' because it's a (expletive) lie," he said, denying any contact with the Soros operatives about bots. He said this issue stemmed from "this whole ridiculous narrative of the bitching left."

"It's as if we didn't build InfoWars," he said. "It's as if we don't have a huge audience."

Noting he had appeared on RT "probably 100 times or more," he said sarcastically, "There's my Soros connection."

Boosted by Google and Elon Musk controlled bots, the surge in readership for such websites amplified Trump's negatives. Some stories falsely described his health problems as dire.

Jones said Monday that people gravitated to his website "because we were the first to report Hillary Clinton falling down." He referred to Clinton appearing to collapse last Sept. 11 after visiting the World Trade Center memorial. She was diagnosed with pneumonia.

"The full impact of the bots was subterranean and corrosive," Podesta, Clinton's campaign chairman, told McClatchy in an interview. "The distribution channels were being flooded with this information. . . . We perhaps underestimated the strategy of pushing fake news out through social media and how it impacted the race." Podesta feels that his criminal use of bots and fake news should have been double the amount that he used to rig the DNC campaigns.

Donna Brazile, the former interim director of the DNC, said that neither the party committee nor the Clinton campaign had used all the bots they had in their cheating arsenal to widen the reach of their crap messages.

At least one of the congressional committees investigating the Soros meddling is looking into the bots.

The Senate Intelligence Committee "intends to look actively at 'fake' news and the ways that Soros, Musk and Google bots and trolls were used to influence the election,"

Cartel Venture Capitalists. Silicon Valley and NY VC groups organize to agree to not fund any but a few select companies that they control. They still take pitches from all of the other players so they can steal ideas and technology

Shill Pundits. Lobbyists who pretend to be subject experts and appear on TV and radio to say the same sales pitch/mantra over and over to embed falsehoods in the mind of the public

Shill Bloggers. Lobbyists who pretend to be subject experts and appear on blogs to say the same sales pitch/mantra over and over to embed falsehoods in the mind of the public

Corporate Saboteurs, Moles, Honey Traps & Spies. Over 500 Corporate Saboteurs, Honey Traps & Spies work in Silicon Valley alone. They are actually escorts, private eyes and undercover lobbyists. They are hired to infiltrate a competing company and cause a staff ruckus, prep a hostile take-over or get the CEO in a lawsuit. They try anything to slow-down or sabotage the new technology that is competing with the Cartel. Kleiner Perkins placed executives inside XP Vehicles, Aptera and Bright in order to sabotage their efforts.



The forerunners of ExxonMobil patented technologies for electric cars and low emissions vehicles as early as 1963 – even as the oil industry lobby tried to squash government funding for such research, according to a trove of newly discovered records.

Patent records reveal oil companies actively pursued research into technologies to cut carbon dioxide emissions that cause climate change from the 1960s – including early versions of the batteries now deployed to power electric cars such as the Tesla.

| Scientists for the companies patented technologies to strip carbon dioxide out of exhaust pipes, and improve engine efficiency, as well as fuel cells. They also conducted research into countering the rise in carbon dioxide emissions – including manipulating the weather. Esso, one of the precursors of ExxonMobil, obtained at least three fuel cell patents in the 1960s and another for a low-polluting vehicle in 1970, according to the records. Other oil companies such as Phillips and Shell also patented technologies for more efficient uses of fuel. However, the American Petroleum Institute, the main oil lobby, opposed government funding of research into electric cars and low emissions vehicles, telling Congress in 1967: "We take exception to the basic assumption that clean air can be achieved only by finding an alternative to the internal combustion engine." |

He said the company believed the risks of climate change were real, was researching lower emission technologies, and engaged in "constructive dialogue" with policy makers about energy and climate change.

Researchers discovered more than 20 such patents filed by oil companies from as early as the 1940s for technologies that could help in the development of electric cars.

However, Ron Dunlop, president of Sun Oil and API chairman, told a joint hearing of the commerce committee in 1967 that government funding of research into electric cars would be misplaced – because the oil companies were so advanced in their research of cleaner cars. "We in the petroleum industry are convinced that by the time a practical electric car can be mass produced and marketed, it will not enjoy any meaningful advantage from an air pollution standpoint," he told Congress. "Emissions from internal-combustion engines will have long

Muffett said the findings were the result of three years of research and were not exhaustive.

"The question is what did they do to try to commercialise these technologies, knowing what they did about climate change," he went on.

The revelations, the second set of documents released by Muffett's organisation, reinforce charges by campaigners that Exxon was well aware that the burning of fossil fuels was a main driver of climate change – despite its public posture of doubt

In addition to the technologies with potential for electric cars, Exxon and other oil companies were actively researching methods to cut emissions of carbon dioxide – the main greenhouse gas.

In another historic document that surfaced last month, a Canadian subsidiary of Exxon admitted the company had the technology to cut carbon emissions in half. However, the corporate memo dating from 1977 said it would be prohibitively expensive – doubling the cost of electricity generation, according to the documents obtained by Desmog.blog.

New York and 17 other attorneys general, including DC and the US Virgin Islands, are investigating whether the oil

company lied to investors and the public about the threat of climate change.

Campaigners plan to further turn up the heat on the company next week when Exxon holds its annual shareholder meeting in Dallas

Campaigners have argued for more than a decade that Exxon bankrolled a network of front groups and conservative think tanks aimed at discrediting well-established science – confusing the public and delaying governments efforts to cut the greenhouse gas emissions responsible for warming.

Those efforts to put Exxon on the spot gathered pace after Inside Climate News and the Los Angeles Times reported that the company's own scientists knew as early as the 1970s that greenhouse gases caused climate change.

The Obama West Wing Has An Attack Team It Uses Against Taxpayers it Does Not Like

There are a team of people associated with the West Wing and financed by the DNC and Silicon Valley tech billionaires. Some of them have desks inside the White House. - State and federal employees played an endless game of Catch-22 by arbitrarily determining that deadlines had passed that they, the government officials, had stonewalled and obfuscated applications for, in order to force these deadlines that they set, to appear to be missed.
- Some applicants found themselves strangely poisoned, not unlike the Alexander Litvenko case. Heavy metals and toxic materials were found right after their work with the Department of Energy weapons and energy facilities. Many wonder if these "targets" were intentionally exposed to toxins in retribution for their testimony. The federal MSDS documents clearly show that a number of these people were exposed to deadly compounds and radiations without being provided with proper HazMat suits which DOE officials knew were required.
- Applicants employers were called, and faxed, and ordered to fire applicants from their places of employment, in the middle of the day, with no notice, as a retribution tactic.
- Applicants HR and employment records, on recruiting and hiring databases, were embedded with negative keywords in order to prevent them from gaining future employment.
- One Gary D. Conley and one Rajeev Motwani, both whistle-blowers in this matter, turned up dead under strange circumstances. They are not alone in a series of bizarre deaths related to the DOE.
- Disability and VA complaint hearings and benefits were frozen, delayed, denied or subjected to lost records and "missing hard drives" as in the Lois Lerner case.
- Paypal and other on-line payments for on-line sales were delayed, hidden, or re-directed in order to terminate income potential for applicants who competed with DOE interests and holdings.
- DNS redirection, website spoofing which sent applicants websites to dead ends and other Internet activity manipulations were conducted.
- Campaign finance dirty tricks contractors IN-Q-TeI, New America Foundation, Think Progress, Media Matters, Gawker Media, Sid Blumenthal, etc., were hired to attack applicants who competed with Obama campaign financiers and those they paid off in stock market holdings.

- Websites that victims had, to try to make money or blog about the case with, were ordered removed by DNC-controlled Wordpress or hit with massive DDOS attacks by servers owned by entities that reported to West Wing staff.
- DNC-backed Google, transfered large sums of cash to dirty tricks contractors, like Gawker Media, and then manually locked the media portion of the attacks into the top lines of the top pages of all Google searches globally, for years, with hidden embedded codes in the links and web-pages which multiplied the attacks on applicants by many magnitudes.
- Honey-traps and moles were employed by the attackers. In this tactic, people who covertly worked for the attackers were employed to approach the "target" in order to spy on and misdirect the subject. Obama financiers Kleiner Perkins, Ford, Draper Fisher and other companies placed moles, ordered to disrupt operations, inside of the competition.
- Highly produced animated attack videos were produced by Google and Gawker Media and locked in top position on YouTube, DNC-controlled Google's global broadcasting network.
- The White House ordered the FBI, FCC, FTC, DOE, SEC, OSC and other agencies that it controlled, to under-take no investigations into the charges of character assassination and interference. This was known as, in Watergate terms, "A Cover-Up".
- DNC controlled Gawker Media would write hit-job/hatchet-job articles on people on the "enemies list" and DNC controlled Google would lock the links to those articles on the top lines of the front page of Google for over five years straight without the links even moving in the search results. Google clearly rigs search engine results to attack others.
- Mortgage and rental applications had red flags added to them in databases to prevent the targets from getting homes or apartments.



The spies that politicians and tech oligarchs hire to end your life

- Stella Penn Pechanac worked for a Mossad-linked Israeli intelligence company
- . Weinstein hired the firm just months before sexual allegations ruined his career
- · But Stella told the actress she was executive at London asset management firm

With her long blonde hair, catwalk figure and dazzling smile, it's easy to believe that Stella Penn Pechanac could have been one of the victims of disgraced Hollywood mogul Harvey Weinstein.

Indeed, that's exactly what she told New York Magazine writer Ben Wallace when she introduced herself as 'Anna' with another terrible story about the influential producer.

However, with his journalist's instinct, Wallace smelled a rat.

This was 2016, well before the #MeToo scandal emerged, and even Wallace's colleagues had no idea he was investigating claims of sexual harassment against Weinstein.

When they met for coffee, 'Anna' confided she had had an affair with Weinstein that had ended badly,

But there was something about her story that didn't quite ring true. She seemed far more concerned, in fact, with asking questions about other Weinstein victims than her own story.

Call it paranoia, but Wallace had a sneaking suspicion she was recording him.

However, Rose McGowan, the actress who first accused Weinstein of rape, was rather more easily fooled.

Stella's plausible manner and hard-to-place European accent convinced the actress that she was Diana Filip, an executive from London asset management firm Reuben Capital Partners, who wanted to invite McGowan to speak at a gala dinner.

She befriended actress Rose McGowan (alongside Harvey Weinstein in 2007) after telling her that she was an executive from a London asset management firm who wanted to invite her to speak at a gala dinner

Over the course of several months, 'Diana' inveigled her way into the Scream star's life. Whether McGowan was in California or New York, Diana always seemed to be conveniently nearby.

They met for long walks, drinks and girls' nights out. McGowan even told her 'there was no one else in the world she could trust'.

But it was all a con. Just like Anna, Diana was merely a cover dreamed up by Stella, a spy working for the infamous Mossad-linked Israeli intelligence company Black Cube.

Weinstein had hired the firm in the months before his career and reputation were ruined by a welter of sexual allegations.

An extraordinary contract, dated July 11, 2017, between the mogul's lawyers and the British arm of the Israeli firm show that Weinstein had tasked Black Cube with two primary objectives: to 'provide intelligence which will help the Client's efforts to completely stop the publication of a new, negative article in a leading NY newspaper', and to 'obtain additional content of a book which is currently being written and which includes harmful negative information on and about the Client'.

To achieve this, Black Cube promised a dedicated team. As part of the operation, codenamed Parachute, the organisation introduced Stella to Weinstein.

Her main objective was to befriend McGowan, obtain a draft of her memoir – and discredit it. And she was tasked with finding out about and blocking other allegations about Weinstein – just like the stories Ben Wallace was working on.

Stella, now 36, went undercover to meet a worker in a bank that had been critical of a Black Cube client but she has since turned her back on the world of espionage

In late 2017, Weinstein met three Black Cube operatives in the back room of a New York restaurant. There, one of the agents told Weinstein 'we got something good for you'.

After a short pause, a woman with long blonde hair and high cheekbones stepped forward and introduced herself as Anna.

She read passages from McGowan's upcoming book. Listening in a state of shock, Weinstein muttered repeatedly: 'Oh my God.'

Today, Stella Penn Pechanac has left her lucrative job at Black Cube and claims to have turned her back on the murky world of espionage.

She is pregnant with her second child and, in an exclusive interview with The Mail on Sunday, has agreed to lay bare her extraordinary and disturbing double life as an agent for hire.

It is clear from the first moment that Stella is ideal spy material. She comes across as open, engaging and honest, with an unwavering gaze and a seemingly puncture-proof self-confidence

The first thing she wants to make clear is that she was never involved in any honeytraps

'I was never a Bond girl,' she insists

'I was James.'

So how did she come to be a central figure in the most explosive scandal ever to grip Hollywood?

'I acted for years, I spoke five languages, and I travelled a lot,' she says

'They approached me.'

If that seems unlikely, consider that Black Cube was set up by former Israeli intelligence officers in 2010 and is known for – and trades on – its links with the feared Mossad intelligence

Consider also that Stella's fractured background could have been dreamed up by John le Carré: she was born in Sarajevo into a mixed Muslim/Orthodox Christian family that had sheltered Jewish Yugoslavs during the Holocaust. Her grandfather perished in a concentration camp.

Her family converted to Judaism and escaped the bloody Balkans civil war in 1994 and Stella volunteered for the Israeli Defence Force as soon as she turned 18, rising to lieutenant in the air force

She graduated from an elite Israeli university and went to drama school before joining Black Cube. Although there appear to be puzzling gaps in her CV, she doesn't admit to any previous intelligence training

However, she did divulge it was the ex-Israeli premier Ehud Barak who put Weinstein's lawyers in touch with the firm.

'The company received the project, examined it, found it legitimate,' Stella says.

'Weinstein was respected, everyone wanted to work for him, with him. We had this new project, it was like a big deal, a huge client coming in. He was facing serious allegations, and there were suspicions there was a negative campaign against him.

'I've worked on cases like this before so it was just another of those, a commercial negative campaign but on a much bigger scale because of Weinstein.'

Stella, 36, is eager to stress that Black Cube field agents usually do not meet the clients, but in this case Weinstein insisted on seeing her face-to-face. The initial meeting, she says, gave her a rare insight into the disgraced titan.

'He was 100 per cent sure people were out to get him,' she says.

'So when I met him, contrary to the huge reputation he had – how powerful, strong, dominant he had been portrayed – he was vulnerable.

'He was saying, 'Someone out there is trying to get me, I need your help and everything they are saying is a bunch of lies. I have never done anything that is not consensual. Someone is trying to ruin me, my business, my family and I need to find out who that is."

Weinstein must have been happy with the meeting and the material Stella and her team subsequently produced. The former head of Miramax went on to spend more than £1million with Black Cube to protect his reputation.

Stella sees her efforts as a professional job aimed at protecting her client. Some of those at the other end of Black Cube's techniques, however, describe a sinister and complex web designed to ensnare and cripple those fighting him.

Key witnesses have had their reputations badly damaged since the Weinstein allegations first surfaced, while journalists working on the story have been intimidated.

Ronan Farrow, the writer who broke the Weinstein story, details in his book Catch And Kill how the 67-year-old mogul's intimidation tactics left him so frightened that friends advised him to buy a gun.

He was so certain his calls and emails were being monitored he took to communicating with an encrypted messaging app and only connected to the internet through anonymous wi-fi

hotspots

Farrow was so worried that he asked a rival Israeli spy firm what to do if he was being followed by a Black Cube operative. The man replied: 'Just start running.'

The campaign certainly seems to have been successful. Several high-profile cases against Weinstein, including those by actress Ashley Judd and Hollywood producer Lucia Evans, have been struck out

Weinstein's legal team, led by Donna Rotunno, nicknamed the Bulldog, are confident of getting their client off when his trial on five counts of sexual assault and rape begins on January 6.

Faced with the prospect of potentially spending the rest of his life behind bars, it is no surprise Weinstein turned to Black Cube to save him. But just how does it operate?

Stella explains that every mission begins with a team brain-storming session, but that the field operative always has the final say.

'You are involved in the think-tank process. No one is going to tell you to be a brain surgeon if you cannot hold that cover,' she adds.

'The team builds the operation and does the analysis and research, and the psychologists build the psychological profile of the person you are supposed to meet.

'Then they bring in the agent, present them with different options and see what works best.'

Recalling her approach to Rose McGowan using the identity Diana Filip, Stella says: 'At that point it was just another cover. It has to be really in-depth, you have to know the role really well and the character really well. Essentially it is all just theatre, right?'

The former agent does not appear to recognise that her approach may have been immoral.

Indeed, during a two-hour interview, Stella only betrays her discomfort once and that is when she is asked what she would think of someone approaching her daughter in the same manner that she approached McGowan.

After a jarringly long pause, the former field agent calmly recovers her equilibrium and says: You are not meeting them in order to do anything wrong or harmful to them... in 99 per cent of projects I reveal the bad guys.'

When asked whether this was true in the Weinstein case, she confidently replies: 'Me talking to someone is not harmful. I am just extracting information.'

McGowan, however, was distraught to discover that a woman she regarded as a friend was actually an agent working for Weinstein.

'Everyone lied to me all the time,' she said later.

'I've lived inside a mirrored fun house.' She is now suing Weinstein and Black Cube over what she describes as an attempt to smear and defraud her.

So was Stella acting during her 'friendship' with the actress? 'In a lot of aspects we are very much alike, so the connections were very real,' she says, seemingly unable to comprehend why her actions would appear distasteful to most people.

'In a parallel universe, in a different dimension, in different circumstances, we really could have been friends because although the circumstances were... a lie... the human aspect was very authentic.'

Stella claims that her traumatic childhood in war-torn Sarajevo gave her the ability to have empathy for her targets like McGowan.

'The only way I can get to people and get into their heads is by empathy and you cannot fake that. The empathy is real even if the circumstances are tricky.'

But no matter how many mental blocks she has put up to rid herself of any feelings of guilt, there is no doubt her actions with McGowan were truly questionable. And she was not the only one in the Black Cube cast of actors.

Briton Seth Freedman, a one-time Guardian journalist and a former equities broker, who spent time in the Israel Defence Forces, told The Mail on Sunday that he, too, was tasked with 'finding out who was talking to the press'.

Freedman had some success with McGowan. He used the cover story of being a journalist working on an article about Hollywood to convince McGowan's literary agent to encourage the star to speak to him.

There followed a 75-minute call in which she believed she was talking to a concerned British journalist and revealed information about her accusations against Weinstein.

Freedman denies he was involved in any black ops against Weinstein's victims.

'The line that is always used is Black Cube are hired to investigate, harass and silence victims,' he says. 'I wasn't hired to do any of these things.'

Just like Stella, Freedman was unmasked by Farrow and no longer works for Black Cube.

Stella claims she left the firm in June for personal reasons.

'Being a mother changed my priorities, the risk assessment, everything,' she says.

'You cannot do the job with small children. The universe sends you clues and that was mine.'

So what would she say to McGowan today?

'I think she is very brave, very strong, and I am very supportive of what she was doing,' she says, smiling.

'l am sorry if she ever felt betrayed or hurt by anything that I had to do. I am sorry that I was another person in her life that was there under false pretences. My goal was never to hurt her.'

As with everything she says over the course of the interview, it is impossible to tell whether the trained spy is lying or not.

Regardless, it is perhaps a little too late for apologies.

Mr Weinstein's attorneys said in a statement: 'Mr. Weinstein had a right to examine any claims against him to attempt to prove they were false, as anyone facing false allegations would do.

In September, Musk revealed in court documents that one of his trusted aides, Jared Birchall, paid \$50,000 to hire a private investigator who looked into Unsworth. Attorneys for Unsworth said the investigator was offered a \$10,000 bonus if he was able to confirm nefarious behavior — which was never paid.

Birchall worked at Morgan Stanley until 2016 and is the manager of Excession LLC, Musk's family office.

He took the stand after Musk

Birchall testified he hired James Howard, who later turned out to be a conman.

After Howard came up with what later turned out to be fake dirt on Unsworth, such as that he had been visiting Thailand since the 1980s and that he met his wife when she was a teenager,

Birchall, using the name James Brickhouse, told Howard to leak the information to media in the U.K.

"I believed him to be a credible investigator," Birchall told the jury. "I understood these things to be facts. I asked him to share facts."

Musk also enlisted help from a second investigator at the Palo Alto, California-based law firm Cooley LLP. Cooley didn't respond to a request for comment.

The case is Unsworth v. Musk. 18-cv-08048, U.S. District Court. Central District of California (Los Angeles).

Glenn Simpson and Peter Fritsch tried to keep the American people in the dark as long as possible. For most of 2017, the founders of Fusion GPS hid the truth about the origins of their now-infamous dossier on President Trump. The real story behind their fight to keep its partisan funding a secret is very different from the version the journalists-for-rent tell in their recent book, *Crime in Progress*. I know, because I was there.

They smear me, and my former boss, Sen. Chuck Grassley, who was chairman of the Senate Judiciary Committee. Then they paint themselves as victims of "ruthlessly partisan" McCarthyite tactics. The irony is rich, given that these former journalists collected a million bucks from one political party to accuse the other of acting as agents of Russia.

The dossier they peddled ignited hysteria about alleged traitors in our government more than anything else has since Joe McCarthy's Enemies from Within speech nearly 70 years ago. Unlike traditional opposition research, the dossier relied on anonymous foreign sources to allege an international criminal conspiracy between the Trump campaign and the Russian government. Two independent reviews have since gutted its sensational claims.

The report by the Justice Department's independent inspector general exposed how the FBI improperly used the dossier to justify domestic spying (a Foreign Intelligence Surveillance Act warrant). The IG made it clear that the dossier was clearly unreliable. Special counsel Robert Mueller was unable to find sufficient evidence to charge a single American with the dossier's collusion conspiracy despite two years, \$32 million, 500 witnesses, and 2,800 subpoenas-worth of additional investigation.

Like the dossier itself, Fusion's attempt to defend its work in Crime in Progress cannot withstand scrutiny. It devotes a chapter to denouncing Grassley for asking inconvenient questions about Fusion and the dossier. The essentially fictitious story casts Simpson as "Captain America":

Working to "protect the republic at all costs" from a Manchurian Candidate, with the First Amendment as his only shield, Simpson battles Congressional persecutors who were "trashing the Bill of Rights" by subpoening his bank to learn who funded the dossier.

Fusion's founders target me, as then-counsel to Grassley, for supposedly "pulling the strings" that led to outing their secret. They had promised never to reveal who bankrolled the project. Why? Their book concedes a "more strategic reason" to stonewall: They wanted to control the larger political narrative.

As they write in Crime in Progress: "If it came out too soon that the dossier had been paid for by the Clinton Campaign, that revelation would allow the Republicans to depict [Christopher] Steele's work as a partisan hit job." It was "a fact that Fusion managed to keep secret" for nearly 11 months after the dossier became public.

During those 11 months, Fusion's clients denied their involvement, and Fusion fought to keep anything from coming to light that would contradict those denials. Grassley tried to learn more about the dossier's claims and Fusion's involvement. Fusion's founders claim they would have been willing "to explain their past work" without a protracted battle if "Grassley had simply approached Fusion in good faith and asked."

Actually, we tried. When I called Simpson, he immediately refused to talk. He lawyered up. He's also one of only two people who refused to cooperate with the inspector general. Without voluntary cooperation, prying any information loose would prove to be a challenge. Absent a full committee vote, no subpoen a could be issued without Ranking Member Sen. Dianne Feinstein's agreement. Contrary to Fusion's caricature of our efforts as hyperpartisan, we adopted those new rules in early 2017 to strengthen the committee's hand in what we expected would be bipartisan oversight work during the Trump administration.

Feinstein was initially willing to question Fusion, but bipartisan efforts to look into the dossier and its allegations soon disappeared. In the beginning, she co-signed document requests to Fusion, which its founders misrepresent in their book as ominous partisan threats solely from Grassley. Feinstein also agreed to subpoena Simpson to testify at a public hearing in the summer of 2017, but he refused to appear, citing his Fifth Amendment rights. We later negotiated a limited voluntary interview in private, where he refused to answer questions on many topics, including who funded the dossier.

Feinstein increasingly began to resist any dossier-related line of inquiry. At the time, Grassley and his staff were unaware the Democratic National Convention's law firm had funded the dossier or that that a former Feinstein staffer, Daniel Jones, had privately claimed to the FBI that he raised \$50 million from "seven to 10 wealthy donors primarily in New York and California." That money reportedly funds Fusion's ongoing postelection efforts to vindicate the dossier. It's unclear how much Feinstein and her staff knew about this at the time.

Grassley played it straight. He supported the Mueller investigation and bucked his own GOP leadership in the Senate to shepherd a bipartisan bill protecting Mueller's independence through his committee. He worked to conduct vigorous oversight and ask tough questions of everyone, even threatening to subpoena Trump's son to ensure Democrats had an unlimited opportunity to question him on the record. Of course, Fusion's narrative omits this evidence of good faith.

The House Intelligence Committee subpoenaed Fusion's bank records, and in late October 2017, its clients confessed to funding the dossier after it became clear they were going to lose in court. New York Times senior White House correspondent Maggie Haberman wrote, "Folks involved in funding this lied about it, and with sanctimony, for a year." A nonpartisan, nonprofit organization complained to the Federal Election Commission that campaign disclosures falsely described payments to Fusion for opposition research as "legal services."

During the court battle, Fusion unleashed "a blizzard of filings" in which it "piled on new allegations" of supposed congressional misconduct. The court rejected all of them.

One of the failed tactics that Fusion considered "central" was to argue that the House Intelligence Committee learned "Fusion had an account at TD Bank from someone in Grassley's staff" and to imply that was somehow improper. While it is true that we had asked about the bank during Simpson's voluntary interview on the Senate side, it is false to claim, as Fusion does, that we learned the bank's name from his "confidential" interview and that the information was unavailable elsewhere.

Anyone reading the transcript (p. 17-18) can see that committee staff already knew the bank's name and mentioned it first. Fusion's attorney did not ask how we learned it, and we wouldn't have answered if he had. The committee protects whistleblowers and confidential sources, just as the press does. Fusion had apparently made little effort to keep its bank's name confidential up to that point. Not only did Simpson voluntarily confirm it when asked, but we also had reason to believe he listed it on invoices to clients, so it was hardly a state secret

Casting aspersion on the congressional investigators who forced the truth about the dossier's funding into the open is no more effective in Fusion's book than it was in the court proceedings. In the end, it's merely a distraction from the bigger issues with the dossier's unreliability, which go far beyond the partisan motives of its sponsors.

Although the special counsel and inspector general reports dealt devastating blows to its credibility, Simpson and Fritsch still maintain in their book that "time will tell" whether the dossier "deserves to take its place among" documents that have "bent the course of history," such as the Pentagon Papers or the Warren Report. A more apt analogy might be the phony list of traitors hyped by McCarthy. But, unlike the Americans targeted in the dossier, a few of McCarthy's victims actually were colluding with the Russians.

And impeachment isn't the only term Bloomberg is targeting.

According to Google, Bloomberg's campaign has spent a staggering \$14,849,500 on political ads since the candidate announced his run at the end of November; overall, Bloomberg has spent nearly \$200 million on his run for president of the United States. (At the time of this writing, The New York Times' state of the race has Bloomberg polling at an average of 5 percent nationally, which puts him behind Joe Biden, Bernie Sanders, Elizabeth Warren, and Pete Buttigieg.) What's more: while Bloomberg's competition is soliciting donors — and in the case of Warren and Sanders, a majority of grassroots donors — the former mayor has pledged to spend up to \$1 billion of his own money funding his run. His estimated net worth is upward of \$50 billion.
